

# TERMS & CONDITIONS "wanna RM5 New Member Sign Up Promotional Campaign"

- 1. The "wanna RM5 New Member Sign Up Promotional Campaign" ("the Campaign") is organized by wannaPay Sdn. Bhd. (1235895-M) ("wanna") ("Organiser").
- 2. By participating in this Campaign, the **Eligible Customers** hereby expressly agreed to be bound by the Terms & Conditions and the decisions made by Organiser. The following sets-out the terms and conditions applicable to the Campaign ("Terms & Conditions").

### **CAMPAIGN PERIOD**

3. The Campaign shall run from **01 May 2022 to 30 June 2022** ("**Campaign Period**").

### ELIGIBILITY

- 4. The Campaign is open to all non-existing wanna users who download and successfully register as a wannaPay user for the first time during the Campaign Period.
- 5. For clarity, those who first-time log in or first-time successful individual applicants of wannaPay account done outside of the Campaign Period shall **not** be eligible to participate in this Campaign.

### MECHANICS

6. The Eligible Customers would need to download the wanna App and successfully sign up an wannaPay account within the Campaign period. This would result in an active wannaPay account for the cash reward to be credited into.

### **REWARDS FULFILLMENT**

- 7. The Eligible Customers will then be rewarded with the cash reward of RM5 which will be credited into their wannaPay account, and this cash reward is only valid for the first 10,000 eligible customers (first come first served basis).
- 8. Fulfilment of the cash reward will be done within 7 working days after successful account registrations.
- 9. The Eligible Customers will be notified of the cashback received through the wanna App and it will be the responsibility of the Eligible Customers to check the notification.

- 12. wanna's decisions on all matters relating to the Campaign will be final and binding, including the determination of eligible customers and Rewards. No correspondence, protests or appeals will be entertained.
- 13. wanna reserves the right to alter, shorten, cancel, suspend or terminate this Campaign or any part thereof by giving at least five (5) days' prior notice via wanna's in-app announcements and/or through any other mode determined by the organiser.
- 14. For the avoidance of doubt, the alteration, shortening, cancellation, suspension or termination by wanna shall not entitle Eligible Customers or any other persons whatsoever to any claim or compensation against wanna for any losses or damages suffered or incurred as a direct or indirect result of the act of alteration, shortening, cancellation, suspension or termination.

Organiser reserve the right to amend the Terms and Conditions and the amended and restated terms and conditions will be published on the official campaign website. The Eligible Customers' continued participation in this Campaign after the publication of the amended and restated terms and conditions will be deemed as the Eligible Customers' acceptance of the amended and restated terms and conditions. wanna reserve the right in their sole and absolute discretion to cancel, modify or suspend this Campaign in whole or in part, without liability to the Eligible Customers. wanna also reserve the right to disqualify the Eligible Customers in its sole discretion.
- 16. The Organiser will not be liable for any default due to any act of God, war, riot, strike, lockout, industrial action, fire, flood, drought, storm, epidemic, pandemic, technical or system failure or any event beyond the reasonable control of Promoters.
