

**TERMS AND CONDITIONS**  
**1 MILLION WANNAREWARDS POINTS**

1. The 1 Million wannaRewards Points Campaign (“Campaign”) is organized by **WANNAPAY SDN. BHD.** (1235895-M) (“wanna”).
2. By participating in this Campaign, the Eligible Participants hereby expressly agreed to be bound by the Terms & Conditions and the decisions made by wanna. The following sets out the terms and conditions applicable to the Campaign (“Terms & Conditions”).

**CAMPAIGN PERIOD**

3. The Campaign shall run from 22 October 2022 until 31 December 2022.
4. wanna reserves the right upon giving adequate prior notice to change the duration and/or the commencement and/or expiry dates of the Campaign Period.

**ELIGIBILITY**

5. This Campaign is open exclusively to all wannaPay users, hereinafter collectively referred to as “Eligible Participant(s)”. The wannaPay account of the Eligible Participant(s) is hereinafter collectively referred to as the “Participating wannaPay Account(s)”.
6. There is no registration required. “Eligible Participant(s)” must fulfil the Eligible Transactions and/or Activities made (as defined in Mechanic).

**MECHANIC**

7. The Eligible Participant(s) can earn qualifying entries (“Qualifying Entry(s)”) by performing any of the Eligible Transaction(s) and/or Activities set out in Table A throughout the campaign period.

8. For the avoidance of doubt, the following transactions are herein expressly excluded and shall not be treated as an Eligible Transaction(s): -
  - a) Top up wannaPay account
  - b) Send and Receive money transfer
  - c) Any unposted, cancelled, void, disputed, refunded, fraudulent or unauthorised transactions
9. All Eligible Transaction(s) will be automatically tracked by wanna for the purpose of meeting the Transaction and Activity Criteria of the Eligible Participant(s). The tracking of the Eligible Transaction(s) is based on the transaction and/or activity dates and/or time (Malaysian Time) as captured by wanna transaction records during the Campaign Period. Any determination by wanna as to what constitutes Eligible Transactions shall be conclusive and shall not be challenged in any manner whatsoever unless the same appears as grossly unfair or unjust.  
wanna shall not be responsible for any failure and/or error and/or delay in the transmission of evidence of Eligible Transaction(s) and Activities and/or posting of the Eligible Transaction(s) to the Eligible Participant(s)' Eligible wannaPay's Accounts by merchant establishments and/or any other party unless the same is due to wanna's wilful default or gross neglect.

12. For clarity, Eligible Participant(s) there is no limit to Daily Prizes throughout the Campaign Period.
13. The Daily Prizes are awarded on a first come first served and while stocks last basis only.
14. wanna shall not be under any obligation to inform users, on any communication channels once the prizes have been fully awarded.
15. The Daily Prizes will be awarded immediately upon the completion of the eligible transactions, where the prizes are still available. The wannaRewards can be viewed under “History” on the “Rewards” tab on the wanna app.
16. The campaign will end when the time runs out, or when the available Rewards are fully awarded, whichever is earlier.
17. wanna’s decisions in any matter about the campaign shall be final and conclusive. wanna shall not be liable for any claims by participants or third-party claims or losses of any nature, including but not limited to, loss of profits, expectation loss, punitive, indirect, special, incidental, or consequential damages or for other damages and any related claims of any nature, including direct, indirect, third-part, consequential or other damages resulting from or in connection with this campaign.
18. The Participating wannaPay Account(s) of the selected Eligible Participant(s) MUST be in good standing and MUST NOT be in breach of any of the terms and conditions of the wanna and/or be invalid or cancelled

as otherwise they will be disqualified from participating in the Campaign.

#### GRAND PRIZE FULFILMENT PROCESS

19. At the end of each Campaign Period, Eligible Participant(s) who has performed the Eligible Transaction(s) and/or Activities and fulfilled the criteria to earn Qualifying Entry(s) as stated in Clauses 7 to 8 above shall be randomly selected by wanna's automated selection system. ("Potential Prize Winners").
20. The announcement of the Prize Winners shall also be made on wanna website and/or wanna social media within sixteen (30 days) from the end of the Campaign.
21. Ten (10) Potential Prize Winners will be shortlisted at the end of the Campaign Period ("Potential Grand Prize Winner").
22. The Potential Grand Prize Winners will be contacted by wanna via telephone at his/her mobile number maintained in wanna's records within sixteen (14) days from the end of the Campaign Period and shall be required to answer two (2) questions correctly to be declared as the "Grand Prize Winner".
23. If the first attempt to contact the Potential Grand Prize Winner fails, due to reasons such as there being no answer, the Potential Grand Prize Winner's telephone number is not in service, the lack of, no connection or for any other reasons whatsoever, a further two (2) attempts will be made to call the said Potential Grand Prize Winner at the same mobile number. 24. If a Potential Grand Prize Winner requests wanna return the call at a later time, the maximum time frame that the Potential Grand Prize Winner may request is one (1) hour later.
25. wanna reserves the right to record these telephone conversations
26. wanna has the sole discretion to fix the appointed working days (Monday - Friday) and time (9 am - 6 pm) to perform the processes outlined under Clauses 22 to 26. wanna shall not be held responsible for any incomplete or disconnected calls due to the unavailability of the Potential Grand Prize Winner at the appointed date and time.
27. The question and answer will be judged and decided by a panel of judges selected by wanna and the decision of the panel of judges shall be final and binding.
28. It shall be the Eligible Participant(s)' responsibility to ensure that their mobile numbers and mailing addresses provided are current and updated with wanna in the event of any changes being made to the same by the Eligible Participant(s). wanna shall not be responsible to the Eligible Participant(s) for any loss (including loss of opportunity and consequential loss flowing therefrom) suffered if the Eligible Participant(s)' mobile numbers in wanna's record is not current or correct.
29. All prizes offered under this Campaign cannot be transferred to a third (3rd) party, exchanged for cash or a different prize or reward of similar value or any other alternatives in any circumstances.

#### GENERAL TERMS AND CONDITIONS

30. The Eligible Participant(s) agree that by participating in the Campaign, they:
  - a) have accessed, read and confirm their agreement to these Terms and Conditions;
  - b) consent to CIMB processing and disclosing their personal data per the wanna Privacy Notice at [www.wanna.com.my](http://www.wanna.com.my);
  - c) agree that all decisions fairly and reasonably made by wanna about every aspect of this Campaign, including the Prizes to be given away and determination of the recipients, shall be final, binding and conclusive; and

- d) agree that wanna shall not be liable or held responsible to the Eligible Participant(s) if wanna is unable to perform in whole or in part any of its obligations in these Terms and Conditions attributable directly or indirectly to:
  - i. the failure of any mechanical or electronic device, data processing system or transmission line;
  - ii. electrical failure;
  - iii. industrial dispute, war, strike or riot;
  - iv. any act of God beyond CIMB's control; or
  - v. any factor in nature of a force majeure which is beyond CIMB's reasonable control.
  
- 31.** The Eligible Participant(s) will be disqualified from participating in the Campaign and/or the prizes will be forfeited if, during the Campaign Period and/or before delivery or giving of the prizes:
  - a) The Eligible Participant(s) are in breach of the terms and conditions governing the Campaign;
  - b) The Participating wannaPay Account(s) is terminated or closed or be made subject to any attachment, adverse orders made by the Court or any authorities sanctioned by laws; or
  - c) The Participating wannaPay Account(s) is invalid or cancelled by the wanna.
  
- 32.** wanna shall have the right to disqualify any Eligible Participant(s) that it determines to be:
  - a) tampering with the entry/participation/application process; and/or
  - b) acting in breach of these Terms and Conditions.
  
- 33.** wanna shall have the right to:
  - a) substitute the prizes with other item(s) of similar cost; and/or
  - b) extend, shorten, discontinue, cancel, terminate or suspend the Campaign.

by giving five (5) calendar days' prior notice to the Eligible Participant(s) via:

  - i. announcement at wanna's website; and/or
  - ii. by any other means of notification which wanna may select.
  
- For the avoidance of doubt, wanna shall not be liable to the Eligible Participant(s) for any losses, damages, costs or expenses as may be suffered or incurred by the Eligible Participant(s) as a direct or indirect result of any Prizes and/or any cancellation, suspension, shortening or extension of the Campaign.
  
- 34.** wanna shall not be liable to any Eligible Participant(s) or any party for any loss or damage (including but not limited to, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages) resulting from the Eligible Participant(s)' participation or non-participation in the Campaign unless such loss or damage arises from and is caused directly by wanna's gross negligence or wilful default.
  
- 35.** wanna shall have the right to vary, add, delete, or amend any of these Terms and Conditions ("Amendment") by giving twenty-one (21) calendar days' prior notice to the Eligible Participant(s) via announcement at wanna's website; and/or by any other means of notification which wanna may select. The Amendment shall be considered binding on the Eligible Participant(s) from the date as specified by wanna in the notification. Eligible Participant(s) agree to access wanna's website at regular intervals to view the terms and conditions of the Campaign and to ensure that they are kept up-to-date with any variation to these Terms and Conditions.

wanna will not be liable to the Eligible Participant(s) for any loss or damage suffered or incurred by the Eligible Participant(s) as a direct or an indirect result of the Amendment.
  
- 36.** The Eligible Participant(s) shall fully indemnify and keep wanna indemnified against any fee, cost, charge, expense, loss, damage or liability which the Bank may incur as a result of the Eligible Participant(s)' participation in the Campaign; and/or b) the Eligible Participant(s)' receipt, redemption or use of the Prizes.
  
- 37.** These Terms and Conditions shall prevail over any provisions or representations contained in any other materials advertising the Campaign; and are to be read together with the prevailing terms and conditions of the Participating wannaPay Account(s) which shall apply in addition to these Terms and Conditions.

38. If the Campaign is ceased or suspended by the relevant authorities or other factors beyond the control of wanna, the Campaign may be terminated immediately by wanna and the Eligible Participant(s) shall have no recourse against wanna.
39. wanna's decision on all matters relating to the Campaign will be final and binding, including the determination of Eligible Participant(s), Potential Grand Prize Winner(s) and Prizes. No correspondence, protests or appeals will be entertained.
40. wanna reserves the right to alter, shorten, cancel, suspend or terminate this Campaign or any part thereof by giving at least five (5) days prior notice via wanna Facebook ([www.facebook.com/mywannatalk](http://www.facebook.com/mywannatalk)) and/or through any other mode in the absolute discretion of wanna.
41. To the fullest extent permitted by law, by participating in this Campaign, the Eligible Participant(s) agree that the Eligible Participant(s) will not hold wanna or their officers, servants, employees, representatives and/or agents (including without limitation, any third-party service providers that the Organizer or wanna may engage for the purposes of this Campaign), liable for any loss or damages that the Eligible Participant(s) may incur, in connection with the Campaign.
42. The Eligible Participant(s) hereby give their consent to and authorize wanna to disclose the Eligible Participant(s)' particulars to the appointed representatives engaged by wanna solely for the purposes of this Campaign, if any, and the disclosure of such particulars to any third party service providers will be limited to the Eligible Participant(s)' name, email address and telephone number and will be used only in relation to and for purposes of this Campaign and in the manner following the provisions of Personal Data Protection Act 2010.
